### SOME LARGE POLYOMINOES' PERIMETER: A STOCHASTIC ANALYSIS

ABSTRACT. In this paper, we analyze the stochastic properties of some large size (area) polyominoes' perimeter such that the directed column-convex polyomino, the column-convex polyomino, the directed diagonally-convex polyomino, the staircase (or parallelogram) polyomino, the escalier polyomino, the wall (or bargraph) polyomino. All polyominoes considered here are made of contiguous, not-empty columns, without holes, such that each column must be adjacent to some cell of the previous column. We compute the asymptotic (for large size n) Gaussian distribution of the perimeter, including the corresponding Markov property of the chain of columns, and the convergence to classical Brownian motions of the perimeter seen as a trajectory according to the successive columns. All polyominoes of size n are considered as equiprobable.

**Keywords**: polyominoes' perimeter, asymptotic Gaussian distribution, Markov property, convergence to classical Brownian motions

### 1. Introduction

In this paper, a polyomino is a set of cells on a square lattice such that every cell of the polyomino can be reached from any other cell by a sequence of cells of the polyomino. The perimeter ( the length of the border) has been the subject of a large literature. We will not provide all references, we refer to the rather complete bibliography given in Bousquet-Mélou [4],[5], Bousquet-Mélou and Brak [6]. Let us also add Feretić and Svrtan [9], Feretić [8], Delest and Fédou [7], Blecher et al. [3], Louchard [19].

In this paper, we analyze the stochastic properties of some large size (area) polyominoes' perimeter such that (precise definitions are given in the text) the directed column-convex polyomino (dcc), the column-convex polyomino (cc), the directed diagonally-convex polyomino (dc), the staircase (or parallelogram) polyomino (st), the escalier polyomino (es), the wall (or bargraph) polyomino (wa). All polyominoes considered here are made of contiguous, not-empty columns, without holes, such that each column (of size j) must be adjacent to some cell of the previous column (of size k). We will denote by U(k,j) (characterizing each polyomino) the possibility function giving the number of ways of gluing the two columns together. We compute the asymptotic (for large size n) Gaussian distribution of the perimeter, including the corresponding Markov property of the chain of columns, and the convergence to classical Brownian motions of the perimeter seen as a trajectory according to the successive columns. confirms the "filament silhouette" of the structures, that had been observed by previous simulations. As said in Flajolet and Sedgewick [10, p.662], "a random parallelogram is most likely to resemble a slanted stack of fairly short segments". This is proved here for all our polyominoes. All polyominoes of size n are considered as equiprobable. The first five ones are treated with similar methods, the bargraph is analyzed with a different technique.

## 2. The DCC PERIMETER

A directed column convex polyomino (dcc) is made of contiguous columns such that the base cell of each column must be adjacent to some cell of the previous column. We have partially considered this polyomino in [16]. In this section, besides the perimeter's analysis, we refine the polyomino stochastic description with another technique, that we will use in all other polyominoes. So we explain it in great detail in this section and provide all necessary notations and computations we use in the sequel.

For dcc, the gluing function is given by U(k,j) = k. Note that it depends only on k, this will not be the case for our following polyominoes. In this paper, we denote by  $\phi(w,\theta,z)$  the three-dimension generating function (GF) where z marks the polyomino's size n (area), w marks the number m of columns (width) and  $\theta$  marks the size j of the last column. All other interesting parameters and stochastic distributions are related to  $\phi(w,\theta,z)$ . In the following subsections, we will first consider  $\phi(w,\theta,z)$  and its derived properties, then the Markov chain corresponding to the dcc, next the perimeter conditioned on the number of columns m and finally the perimeter conditioned on the size n. Asymptotic relations always means when  $n \to \infty$ .

2.1. **The generating functions.** To compute the generating functions we will use the "adding of a slice" technique, initiated by Temperley [21], popularized by many combinatorists (see for instance Bousquet-Mélou [5]) and summarized in Flajolet and Sedgewick [10, p.366]. The analysis we apply here to dcc has already been initialized in [17] for cc, but for the sake of completeness, we present it again here, with some complements.

We denote by  $T(m, n, j, \ell)$  the total number of dcc with area n, width m, last column size j and first column size  $\ell$  (similar notations for partially parametrized T()).

For any function  $g(\theta, ...)$ , set:

$$g'(\theta, ..) \doteq \partial_{\theta} g(\theta, ..).$$

When we use the symbol  $\doteq$  (and similarly for  $\sim$ ), this corresponds to a relation valid for *all* polyominoes, otherwize, the usual := corresponds to the particular polyomino under consideration. Denote by  $\varphi(m,j,z)$  the GF corresponding to polyominoes with m columns, last column of size j and any first column's size. We have

$$\varphi(m,j,z) = \sum_{k=1}^{\infty} k\varphi(m-1,k,z).$$

Now we mark j by  $\theta$ . This leads to

$$\Gamma(m,\theta,z) \doteq \sum_{j=1}^{\infty} \theta^{j} \varphi(m,j,z) = \sum_{j=1}^{\infty} \theta^{j} z^{j} \sum_{k=1}^{\infty} k \varphi(m-1,k,z) = \tilde{f}_{2}(\theta,z) \Gamma'(m-1,1,z),$$

$$\tilde{f}_{2}(\theta,z) = \theta z / (1-\theta z), \Gamma(1,\theta,z) \doteq \tilde{f}_{0}(\theta,z), \tilde{f}_{0}(\theta,z) = \tilde{f}_{2}(\theta,z).$$

Set

$$\Gamma(m,\theta,z) \doteq z^m \theta \Delta(m,\theta,z), \Gamma'(m,\theta,z) \doteq z^m \Delta(m,\theta,z) + z^m \theta \Delta'(m,\theta,z), \text{ hence}$$

$$\Delta(m,\theta,z) \doteq f_1(\theta,z) \Delta(m-1,1,z) + f_2(\theta,z) \Delta'(m-1,1,z), m \geq 2,$$

$$f_2(\theta,z) = 1/(1-\theta z), f_1(\theta,z) = f_2(\theta,z),$$

$$\Delta(1,\theta,z) \doteq f_0(\theta,z), f_0(\theta,z) = f_2(\theta,z).$$

Define

$$\psi(\xi,\theta,z) \doteq \sum_{m=1}^{\infty} \xi^m \Delta(m,\theta,z).$$

We obtain

$$\psi(\xi,\theta,z) \doteq \xi[f_0(\theta,z) + f_1(\theta,z)D_1(\xi,z) + f_2(\theta,z)D_2(\xi,z)], \text{ with}$$

$$D_1(\xi,z) \doteq \psi(\xi,1,z), D_2(\xi,z) \doteq \psi'(\xi,1,z), \text{ and}$$

$$\phi(w,\theta,z) \doteq \sum_{w=1}^{\infty} w^m \Gamma(m,\theta,z) \doteq \theta \psi(wz,\theta,z).$$

To obtain  $D_1$ ,  $D_2$ , we compute

$$\psi'(\xi,\theta,z) \doteq \xi [f_0'(\theta,z) + f_1'(\theta,z)D_1(\xi,z) + f_2'(\theta,z)D_2(\xi,z)],$$

$$(1) \qquad D_1(\xi,z) \doteq \xi [f_0(1,z) + f_1(1,z)D_1(\xi,z) + f_2(1,z)D_2(\xi,z)],$$

(2) 
$$D_2(\xi,z) \doteq \xi[f_0'(1,z) + f_1'(1,z)D_1(\xi,z) + f_2'(1,z)D_2(\xi,z)].$$

Solving, we get

$$D_1(\xi,z) \doteq \frac{N_1(\xi,z)}{h(\xi,z)}, D_2(\xi,z) \doteq \frac{N_2(\xi,z)}{h(\xi,z)},$$

$$N_1(\xi,z) = \xi(z-1), N_2(\xi,z) = -\xi z, h(\xi,z) = -z^2 + 2z + \xi - 1,$$

and setting  $\xi = zw$ , this gives

$$N_1(w,z) = zw(z-1), N_2(w,z) - z^2w, h(w,z) - z^2 + 2z + zw - 1.$$

The root of smallest module of  $h(1,\rho)=0$  is given by  $\rho=\frac{3-\sqrt{5}}{2}=\frac{1}{\phi^2}$ , where  $\phi$  is the golden ratio.

$$\phi(w,\theta,z) \doteq \theta \psi(wz,\theta,z) \doteq w\theta z [f_0(\theta,z) + f_1(\theta,z)D_1(w,z) + f_2(\theta,z)D_2(w,z)],$$

 $f_0(\theta, z)$  corresponds of course to the first column. In order not to burden the notations, we use indifferently  $F(\xi)$ , F(w), where  $\xi = zw$ , clearly depending on the context. Note that we recover  $\rho$ , already computed in [16], in a simple way.

If we set  $\theta = 1$  in  $\phi$ , we have  $D_1(w, z)$ . When w = 1, this gives the GF of the total number T(., n) of size n dcc. By classical singularity singularity analysis, this leads to

$$T(.,n) \sim \frac{C_1}{\rho^n}, n \to \infty, C_1 \doteq -\frac{N_1(1,\rho)}{\rho h_z(1,\rho)} = \frac{1}{2} - \frac{\sqrt{5}}{10}.$$

But we get more. By Bender's theorems 1 and 3 in [1]  $^1$ , (see also Flajolet and Sedgewick, [10, Thm.IX.9]) we derive the asymptotic distribution of the width M, given area n. Let  $F_z$  mean differentiation of F w.r.t. z, and similarly for other notations. Set

$$r_{1} \doteq -h_{w}/h_{z} = -\frac{z}{-2z+2+w},$$

$$r_{2} \doteq -(r_{1}^{2}h_{zz} + 2r_{1}h_{zw} + h_{w} + h_{ww})/h_{z} =$$

$$= -z(-6z + 2w + 4z^{2} - 4zw + w^{2})/(-2z+2+w)^{3},$$

$$\mu_{1} \doteq -r_{1}/\rho = \frac{\sqrt{5}}{5}, \sigma_{1}^{2} \doteq \mu_{1}^{2} - r_{2}/\rho = 2\frac{\sqrt{5}}{25}.$$

Then Bender's theorems lead to

**Theorem 2.1.** The width M of a dcc of large given area n is asymptotically Gaussian: <sup>2</sup>

(3) 
$$\frac{M-n\mu_1}{\sqrt{n}\sigma_1} \stackrel{\mathcal{D}}{\sim} \mathcal{N}(0,1) = \tau_0, \, say, \, n \to \infty,$$

also a local limit theorem holds:

$$T(m,n) \sim \frac{C_1}{\rho^n} \frac{e^{-(m-n\mu_1)^2/(2n\sigma_1^2)}}{\sqrt{2\pi n}\sigma_1}, n \to \infty, m-n\mu_1 = \mathcal{O}(\sqrt{n}).$$

The verification of condition (V) of Bender's Theorem 3 (which is essential to go from a central limit theorem to a local limit theorem) is easy: the function h(w,z) has the following property:  $h(e^s,z)$  is analytic and bounded for

$$|z| \leq |r(\Re(s))|(1+\delta)$$
 and  $\varepsilon \leq |\Im(s)| \leq \pi$ 

for some  $\varepsilon > 0$ ,  $\delta > 0$ , where r(s) is the suitable solution of the equation  $h(e^s, r(s)) = 0$  (i.e. with  $r(0) = \rho$ ). This will be valid for all functions h(w, z) used in the following sections.

Now if we fix m and consider n as a variable (there are, of course, an infinite number of dcc for a given m), we can obtain another asymptotic expression for T(m, n). The

conditioned distribution is given by

$$[w^m z^n] D_1(w,z) \doteq \frac{1}{\rho^n} [w^m z^n] D_1(w,\rho z).$$

For z = 1, the dominant singularity of  $D_1(w, \rho)$  is w = 1. With

$$C_2 \doteq -\frac{N_1(1,\rho)}{h_w(1,\rho)} = \frac{\sqrt{5}-1}{2}, C_2 \doteq C_1/\mu_1, \mu_2 \doteq 1/\mu_1 = \sqrt{5}, \sigma_2^2 \doteq \sigma_1^2/\mu_1^3 = 2.$$

We derive the following theorem

**Theorem 2.2.** For a large given width m, T(m,n) is asymptotically given by

$$T(m,n) \sim \frac{C_2}{\rho^n} \frac{e^{-(n-m\mu_2)^2/(2m\sigma_2^2)}}{\sqrt{2\pi m}\sigma_2}, m \to \infty, n-n\mu_2 = \mathcal{O}(\sqrt{m}).$$

Let us now turn to the asymptotic GF  $G(\theta)$  of the last column size. We first compute

$$[z^n]\phi(1,\theta,z) \sim \frac{\theta\rho[f_1(\theta,\rho)N_1(1,\rho) + f_2(\theta,\rho)N_2(1,\rho)]}{-\rho^n\rho h_z(1,\rho)}, n \to \infty$$

uniformly for  $\theta$  in some complex neighbourhood of the origin. This may be checked by the method of singularity analysis of Flajolet and Odlyzko, as used in Flajolet and Soria [11].

Normalizing by T(.,n), this leads to the following theorem

### Theorem 2.3.

$$G(\theta) \doteq \theta \rho \left[ f_1(\theta, \rho) + f_2(\theta, \rho) \frac{N_2(1, \rho)}{N_1(1, \rho)} \right],$$

$$\pi(j) \doteq [\theta^j] G(\theta) = \rho^j \left( 1 + \frac{N_2(1, \rho)}{N_1(1, \rho)} \right) = \rho^j \frac{\sqrt{5} + 1}{2}.$$

But multiplying (1),(2) by h(w,z) and letting  $w \to 1, z \to \rho$ , we have

(4) 
$$N_1(1,\rho) \doteq \rho[f_1(1,\rho)N_1(1,\rho) + f_2(1,\rho)N_2(1,\rho)],$$

$$N_2(1,\rho) \doteq \rho[f'_1(1,\rho)N_1(1,\rho) + f'_2(1,\rho)N_2(1,\rho)].$$

Hence

$$G(1) \doteq 1, G'(1) \doteq 1 + \frac{N_2(1,\rho)}{N_1(1,\rho)} = \frac{\sqrt{5}+1}{2}.$$

Let us analyze the asymptotic distribution of the last column size in a dcc of large area n and width m. Again Bender's theorems lead to the following GF (the notation is clear here)

$$T(m,n,\theta) \sim \frac{e^{-(m-n\mu_1)^2/(2n\sigma_1^2)}}{\sqrt{2\pi n}\sigma_1} \frac{1}{-\rho^n \rho h_z(1,\rho)} \theta \rho [f_1(\theta,\rho)N_1(1,\rho) + f_2(\theta,\rho)N_2(1,\rho)], \text{ or } T(m,n,\theta) \sim \frac{C_1}{\rho^n} \frac{e^{-(m-n\mu_1)^2/(2n\sigma_1^2)}}{\sqrt{2\pi n}\sigma_1} G(\theta) \doteq \frac{C_2}{\rho^n} \frac{e^{-(n-m\mu_2)^2/(2m\sigma_2^2)}}{\sqrt{2\pi m}\sigma_2} G(\theta),$$

$$n \to \infty, m - n\mu_1 = \mathcal{O}(\sqrt{n}), m \to \infty, n - n\mu_2 = \mathcal{O}(\sqrt{m}).$$

We now turn to the case where the first column possesses i cells. This leads to (note that h(w, z) remains the same, independently of i)

$$\Gamma(1,\theta,z) \doteq \theta^{i}z^{i}, f_{0}(\theta,z,i) \doteq \theta^{i-1}z^{i-1}, f'_{0}(\theta,z,i) \doteq (i-1)\theta^{i-2}z^{i-1},$$

$$N_{1}(w,z,i) = (-z^{2} + z^{2}wi + 2z - zwi - 1 + zw)zwz^{i-1},$$

$$D_{1}(w,z,i) \doteq \frac{N_{1}(w,z,i)}{h(w,z)},$$

$$N_{2}(w,z,i) = -z^{i-1}zw(iz^{2} - 2iz + 2z + i - 1 - z^{2} + z^{2}wi - zwi + zw),$$

$$D_{2}(w,z,i) \doteq \frac{N_{2}(w,z,i)}{h(w,z)},$$

$$C_{2}(j) \doteq -\frac{N_{1}(1,\rho,j)}{h_{w}(1,\rho)} = j(-2 + \sqrt{5})\rho^{j-1}, \sum_{j} C_{2}(j) = C_{2}.$$

Note that  $C_2(j)$  is exponentially decreasing with j. This will be the case for all following polyominoes.

$$\phi(w,\theta,z,i) \doteq w\theta z \left[ f_0(\theta,z,i) + f_1(\theta,z) \frac{N_1(w,z,i)}{h(w,z)} + f_2(\theta,z) \frac{N_2(w,z,i)}{h(w,z)} \right].$$

But we also check that  $G(\theta)$  is independent of i (which is probabilistically obvious): equ.(4) is still valid and shows that  $\frac{N_2(1,\rho,i)}{N_1(1,\rho,i)}$  is independent of i.

2.2. **The Markov chain (MC).** We consider two successive columns  $m_1$ ,  $m_1 + 1$ , of size k, j, such that their distances from the first and the last column are of order  $\mathcal{O}(n)$ . Let  $\Xi(m, n, m_1, k, j)$  denote the total number of dcc with area n, width m, column  $m_1$  of size k, column  $m_1 + 1$  of size j and set  $m_2 := m - m_1$ . Theorem 2.2 leads to

$$\begin{split} \Xi(m,n,m_1,k,j) &\doteq \sum_{n_1} T(m_1,n_1,k,.) U(k,j) T(m_2,n-n_1,.,j), \\ \frac{\Xi(m,n,m_1,k,j)}{T(m,n)} &\sim \sum_{n_1} \left[ \frac{C_2}{\rho^{n_1}} \frac{e^{-(n_1-m_1\mu_2)^2/(2m_1\sigma_2^2)}}{\sqrt{2\pi m_1}\sigma_2} \pi(k) U(k,j) \frac{C_2(j)}{\rho^{n-n_1}} \frac{e^{-(n-n_1-m_2\mu_2)^2/(2m_2\sigma_2^2)}}{\sqrt{2\pi m_2}\sigma_2} \right] \\ & \left/ \left[ \frac{C_2}{\rho^n} \frac{e^{-(n-m\mu_2)^2/(2m\sigma_2^2)}}{\sqrt{2\pi m}\sigma_2} \right]. \end{split}$$

Hence the asymptotic stationary distribution of two intermediate successive columns is given by

$$P(k,j) \doteq \pi(k)U(k,j)C_2(j) = \pi(k)kC_2(j).$$

This leads to the asymptotic stationary distribution  $\pi_2(k)$  and to the MC transition matrix  $\Pi(k,j)$ :

Theorem 2.4.

$$\pi_{2}(k) \doteq \sum_{j} P(k,j) \doteq \sum_{j} \pi(k) U(k,j) C_{2}(j), \text{ or }$$

$$\pi_{2}(j) \doteq \sum_{k} P(k,j) \doteq \sum_{k} \pi(k) U(k,j) C_{2}(j),$$

$$\Pi(k,j) \doteq \frac{P(k,j)}{\sum_{j} P(k,j)} \doteq \frac{U(k,j) C_{2}(j)}{\sum_{j} U(k,j) C_{2}(j)} = \frac{C_{2}(j)}{\sum_{j} C_{2}(j)} = \frac{C_{2}(j)}{C_{2}} = j\rho^{j},$$

$$\sum_{k} \pi_{2}(k) \Pi(k,j) \doteq \sum_{k} \sum_{u} P(k,u) \frac{P(k,j)}{\sum_{j} P(k,j)} \doteq \pi_{2}(j),$$

$$\pi_{2}(k) = \pi(k) k C_{2} = k\rho^{k}.$$

Eq. (5) confirms that  $\pi_2(k)$  is the stationary distribution of  $\Pi(k,j)$ . This shows that the thickness of the polyomino is  $\mathcal{O}(1)$ . This will be the case for all following polyominoes.

A question we could ask is: is the chain reversible, i.e. is the following relation true?

$$\pi_2(k)\Pi(k,j) \doteq \pi_2(j)\Pi(j,k) \equiv P(k,j) \doteq P(j,k).$$

This is satisfied here.

The chain is irreducible and ergodic. Moreover, it is clear that the successive columns are independent and identically distributed (iid). Mean and variance of the stationary distribution  $\pi_2(k)$  are given by

$$\mu_2 \doteq \sum_j \pi_2(j) j = \sqrt{5}, \sigma_x^2 \doteq \sum_j \pi_2(j) j^2 - \mu_2^2 = 2 \equiv \sigma_2^2,$$

by independence of successive columns. We now recover Sec. 2.1 results. Several other interesting relations can be derived. We have

$$\frac{C_2(k)}{\rho^n} \frac{e^{-(n-m\mu_2)^2/(2m\sigma_2^2)}}{\sqrt{2\pi m}\sigma_2} \sim \sum_j U(k,j) \frac{C_2(j)}{\rho^{n-k}} \frac{e^{-(n-k-(m-1)\mu_2)^2/(2(m-1)\sigma_2^2)}}{\sqrt{2\pi(m-1)}\sigma_2}, \text{ hence}$$

$$C_2(k) \doteq \sum_j U(k,j)C_2(j)\rho^k,$$

$$\frac{\pi_2(k)}{\pi(k)} \doteq \sum_j U(k,j)C_2(j) \doteq \frac{C_2(k)}{\rho^k},$$

$$\Pi(k,j) \doteq \frac{\pi(k)U(k,j)C_2(j)}{\pi_2(k)} \doteq \frac{\rho^k}{C_2(k)}U(k,j)C_2(j) \doteq \frac{\pi(k)}{\pi_2(k)}U(k,j)\rho^j \frac{\pi_2(j)}{\pi(j)}.$$

 $\Pi(k,j)$  decreases exponentially with j as well as  $\pi_2(k)$  and  $[\Pi]^{\ell}(k,j)$  converges exponentially fast to  $\pi_2(j)$ . The process is  $\varphi$ -mixing (see Billingsley [2, p.168ff] and Appendix A.1). We will have the same properties for the following polyominoes. Also

$$\frac{\pi(j)}{\rho^j} \doteq \frac{\pi_2(j)}{C_2(j)} \doteq \sum_k \pi(k) U(k,j),$$

$$C_2 \doteq \sum_k C_2(k) \text{ if starting with any first column's size.}$$




FIGURE 1. Two columns of a dcc polyomino and their related parameters.

2.3. The perimeter conditioned on the width m. In the sequel, polyominoes of width m can be seen as a sequence of id RV (columns)  $x_i$ ,  $i = 1, 2, ..., x_m$  by the MC  $\Pi(k, j)$ . In this section, we fix m and analyze the asymptotic properties of the perimeter  $P_m$ . For dcc, we have the following notations and probabilistic relations: see Fig.1,

 $w_d := ($  upper cell position of column d) - ( upper cell position of column d-1),  $z_d := ($  lower cell position of column d+1) - ( lower cell position of column d),  $z_d \ge 0$  depends only on  $x_d$  and is uniformly distributed  $(0, x_d-1)$ ,  $u_d \ge 1$  depends only on  $x_d$  and is uniformly distributed  $(1, x_d)$ ,

$$w_d = x_d - u_{d-1}, z_d = x_d - u_d, T_d := |w_d| + z_d.$$

the total perimeter  $P_m$  the asymptotic vertical perimeter  $Q_m$  the asymptotic total perimeter  $R_m$  are given by

$$P_m \doteq Q_m + x_0 + x_m + 2m, Q_m \doteq \sum_{1}^{m} T_d, R_m \doteq Q_m + 2m, X_m \doteq \sum_{1}^{m} x_d,$$

 $\mathbb{V}(X_m) \sim m\sigma_2^2$ , ( $\mathbb{V}(.)$  denoting the variance),

$$\mathbb{E}(P_m) \stackrel{\cdot}{\sim} \mathbb{E}(Q_m) + 2m, \mathbb{V}(P_m) \stackrel{\cdot}{\sim} \mathbb{V}(Q_m), \mathbb{E}(X_m) \stackrel{\cdot}{\sim} m\mu_2, Cov(P_m, X_m) \stackrel{\cdot}{\sim} Cov(Q_m, X_m).$$

We compute now the first probability densities

In this subsection, we obtain convergence to Brownian motions of  $X(\lfloor vt \rfloor)$ ,  $Q(\lfloor vt \rfloor)$ , and we compute asymptotic mean and variance of R conditioned on n, denoted by  $\overline{R}(n)$ . First of all we fix the width to m. By the function central limit theorem for dependent random variables (RV) and by the mixing property (see, for instance, Billingsley [2, p.168ff]), we obtain the following conditioned on m convergences (where  $B_{\cdot}(t)$  are standard Brownian motions), and these convergences will be valid for the following polyminoes,

Note that, in some cases (here and in the wall polyomino case) our technique leads to exact values for  $\mu_4$ ,  $\sigma_4^2$ . We have made extensive simulations to check our results. We first construct  $T_s = 400$  times a MC X(d), d = 1..m based on  $\Pi(k,j)$  with m = 400 steps. This allows to check the values  $\mu_2$ ,  $\sigma_2^2$ . The fit is excellent. Next we extend ( or contract) each MC such that  $X(m^*) = n$ , with  $n = \lfloor m/\mu_1 \rfloor$ . Based on each MC, we build on each column d a vertical perimeter  $T_d$  following the distribution of Sec. 2.3. We then compare the observed distribution of the vertical perimeter  $Q(m^*)$  with the theoretical parameters  $\mu_4^*$ ,  $\sigma_4^{*2}$ , where

Indeed, we don't take the 2*m* horizontal perimeter into account. The fit is quite good. Let us finally make four remarks

- Actually, we can use Bender's theorems in another way: it is possible to derive large deviations results for all our convergence to Gaussian variables theorems: see for instance Louchard [17]. We will not detail these applications here.
- If we compare exact distributions with the Gaussian limits, we observe a bias, for instance for n = 30. This can be corrected with Hwang [14, Thm.2], Hwang [15]. (See also Flajolet and Sedgewick [10, Lemma IX.1]). See an example in Louchard [17].
- The maximum thickness of the polyomino can also be analyzed. See for instance Louchard [18].
- The trajectories of the polyomino (upper and lower trajectories) lead themselves to Brownian motions: see [16] for dcc and [18] for cc, dc. The polyomino can be seen as a Brownian motion with some thickness. A more detailed analysis will be the object of a future report.
- 2.5. **A comparison with known GF.** In some cases, we know the joint GF of n and  $R_n$ . For instance, for dcc, this is given in Bousquet-Mélou [5, (10)] <sup>3</sup>. If we set q = z, y = 1, x = v in the denominator of (10), we we recover of course h(w, z), leading to the root  $\rho$ . If we set q = z, y = x = v, we obtain <sup>4</sup>

This corresponds to the half-perimeter  $R_n/2$ . Using again Bender's theorems, we obtain

# 3. The CC Perimeter

3.1. **The generating functions.** A column-convex polyomino (cc), is made of contiguous columns such that at least one cell of each column must be adjacent to some cell of the previous column. We first recall from [17] the main expressions we need: starting with any first column's size, and with the same notations as in the previous section,




FIGURE 2. Two columns of a cc polyomino and their related parameters.

We must first dispense from the singularity. But




Figure 3. Simulation of  $\frac{X(v)-\mu_2 v}{\sqrt{1000}\sigma_2}$ , v=1..1000




Figure 4. Simulation of  $\frac{Q(v)-\mu_3 v}{\sqrt{1000}\sigma_Q}$ , v=1..1000




FIGURE 5. A typical polyomino




FIGURE 6. Zoom on our typical polyomino

Again, we have made extensive simulations to check our results. The fit is quite good. Let us illustrate our results by a few figures. We have chosen the cc polyomino as it shows a Markov property (the dcc polyomino is characterized by iid columns). In Fig.3, we show a simulation of  $\frac{X(v)-\mu_2 v}{\sqrt{1000}\sigma_2}$ , v=1..1000, In Fig.4, we show a simulation of  $\frac{Q(v)-\mu_3 v}{\sqrt{1000}\sigma_Q}$ , v=1..1000. The trajectories are strongly oscillating, a classical property of Brownian motions. Fig.5 shows a typical polyomino, with its "filament silhouette". Fig.6 gives a zoom on this polyomino: its width is clearly  $\mathcal{O}(1)$ .

3.4. **A comparison with known GF.** Here, we use Bousquet-Mélou [5, (29)]<sup>6</sup>. If we set q = z, x = w, we obtain

which is exactly h(w, z).

The denominator of

gives a function F(v,z) which leads exactly, by Bender's theorems to  $\mu_4$ ,  $\sigma_4^2$ .

## 4. The DC Perimeter

4.1. The generating functions. A directed diagonally-convex polyomino (dc) is made of diagonals such that all cells on a diagonal are contiguous and each cell is adjacent to one cell of the previous diagonal. By a rotation of  $45^{\circ}$ , this leads to a lattice where the dc is made of contiguous columns such that each cell of each column must be diagonally

adjacent to some cell of the previous column. Note carefully that we don't have here an horizontal perimeter contribution. Note also that this polyomino is different from the directed and convex polyomino described in Bousquet-Mélou [5]: this last one may have holes in a diagonal. Let us finally remark that our results offer a quite different form from Feretić and Svrtan [9, Thm.5] and Feretić [8, Thm.2].

We extract from [17] some relations we had already obtained, starting from 1 cell:

We can check that  $D_1$ ,  $D_1$  are meromorphic functions for |w| < 1, |z| < 1. The convergence in the j summations is quite fast. Usually 6 or 7 terms are sufficient. To be sure that  $\rho$  is the dominant singularity, we can use the principle of the argument of Henrici

[12]: the number of solutions of an equation f(z) = 0 that lie inside a simple closed curve  $\Gamma$ , with f(z) analytic inside and on  $\Gamma$ , is equal to the variation of the argument of f(z) along  $\Gamma$ , a quantity also equal to the winding number of the transformed curve  $f(\Gamma)$  around the origin. See the application in [17].

Let us now start with the case a first column of i cells, (this was not developed in [17])




Figure 7. Three possibilities of a dc polyomino.

4.2. The perimeter conditioned on n. For dc, we have the following possibilities: see Fig.7. The possibility function is given by  $U(k,j) = (k-j+2)[[j \le k+1]]$ . We note that if we add a cell at the upper or lower previous cell position of column d-1, we increase the perimeter by 2, otherwise, the perimeter doesn't change. Hence the first moments are computed as

 if  $k = j+1$ ,  $E_{w^2}(k,j) = 16$ , if  $k \le j$ ,  $E_{w^2}(k,j) = \frac{1}{k-j+2}(1\cdot 4 + 1\cdot 4) = \frac{8}{k-j+2}.$

Finally, we apply the results from previous sections, and we make the following substitutions (note that we divide again by w) in

in  $\theta[B_{1,1}(\xi, \theta, \rho)N_1(w, \rho, i) + B_{1,2}(\xi, \theta, \rho)N_2(w, \rho, i)] / w,$ 

and we obtain

$$\mu_3 = 2.2705856475\ldots, \rho_{X,Q} = 0.5713021769\ldots,$$
 
$$\mu_4 = 1.7394051099\ldots, \sigma_3^2 = .9808725500\ldots$$
 
$$\sigma_4^2 = 0.38150889574\ldots, \sigma_Q^2 = 0.362055589\ldots, \text{ again } \sigma_X^2 \equiv \sigma_2^2.$$

Again, we have made extensive simulations to check our results. The fit is quite good.

### 5. The staircase perimeter

A staircase (or parallelogram) polyomino (st), is made of contiguous columns such that the base cell of each column must be adjacent to some cell of the previous column and the top cell of each column must be adjacent to some cell of the next column.

5.1. **The generating functions.** We proceed as in the previous sections. Starting with a first column of size i, we have

$$U(k,j) = j \text{ if } j \le k, U(k,j) = k \text{ if } j > k.$$

The preliminary relations are

5.2. **The Markov chain.** If  $j \le k$ , we denote any function F(k,j) by  $F^m(k,j)$  and by  $F^p(k,j)$ , Otherwise, this gives

\Pi^{p}(k,j) \doteq \pi(k)kC_{2}(j)/\pi_{2}(k), j > k, 
\pi_{2}(k) = \pi(k) \left[ \sum_{j=1}^{k} jC_{2}(j) + \sum_{j=k+1}^{\infty} kC_{2}(j) \right], 
\pi_{2}(j) = C_{2}(j) \left[ \sum_{k=j}^{\infty} \pi(k)j + \sum_{k=1}^{j-1} \pi(k)k \right].$$




FIGURE 8. Two columns of a st polyomino and their related parameters.

5.3. **The perimeter conditioned on** n**.** For st, we have the following notations and probabilistic relations: see Fig.8,

As previously, we have made extensive simulations to check our results. The fit is quite good.

5.4. **A comparison with known GF.** Now we use Bousquet-Mélou [5, Thm. 3.2]. If we set q = z, y = 1, x = w in the denominator  $J_0(1)$ , we obtain a function

$$\sum_{n=0}^{\infty} \frac{(-1)^n w^n z^{n(n+1)/2}}{(z;z)_n^2}$$

which is another form of

$$h(w,z) = 1 - \tilde{B}_1(\xi,z).$$

If we set q = z, y = x = v, we obtain

$$F(v,z) = \sum_{n=0}^{\infty} \frac{(-1)^n v^n z^{n(n+1)/2}}{(z;z)_n (vz;z)_n}$$

which leads exactly, by Bender's theorems to  $\mu_4$ ,  $\sigma_4^2$ . This last analysis is also given in Flajolet and Sedgewick [10, Prop.IX.11]

### 6. The escalier perimeter

The escalier polyomino (es) is made of contiguous columns with all base cells at the same level, such that, if the size of a column is k and the size of the next column is j, we must have  $j \ge k - 1$ . Let us remark that our results offer a quite different form from Feretić [8, Prop.2].




FIGURE 9. A typical es polyomino.

6.1. **The generating functions and Markov chain.** For es, we have the following typical example: see Fig.9,

We have here  $U(k,j) = [[j \ge k-1]]$ . Starting with a first column of size i,

$$\varphi(m,j,z) = z^{j} \sum_{k=1}^{j+1} \varphi(m-1,k,z), \varphi(1,i,z) = z^{i},$$

$$\Gamma(m,\theta,z) = f_{1}(\theta,z)\Gamma(m-1,\theta z,z) - \varphi(m-1,1,z),$$

with 
$$f_1(\theta, z) = \frac{1}{\theta z (1 - \theta z)}$$
,  $\Gamma(1, \theta, z) = \theta^i z^i$ .

This polyomino is quite different from other polyominoes and our usual techniques do not work anymore. The presence of  $\theta$  in the denominator of  $f_1(\theta, z)$  excludes a direct iteration procedure. We must turn to another approach. We are indebted to H.Prodinger and S.Wagner for providing a new analysis: [20]. First of all, let us change the notations. Starting with a first column of size 1, we have

$$f(n,j,z) = \varphi(n+1,j+1,z),$$

$$f(0,0,z) = z, f(0,k,z) = 0 \text{ for } k \ge 1,$$

$$\varphi(m,j,z) = z^{j} \sum_{1 \le k \le j+1} \varphi(m-1,k,z),$$

$$\varphi(m+1,j,z) = z^{j} \sum_{0 \le k \le j} \varphi(m,k+1,z),$$

$$\varphi(m+1,j+1,z) = z^{j+1} \sum_{0 \le k \le j+1} \varphi(m,k+1,z),$$

$$f(n,j,z) = z^{j+1} \sum_{0 \le k \le j+1} f(n-1,k,z).$$
Now set
$$F(x,y,z) = \sum_{n \ge 0} \sum_{j \ge 0} x^{n} y^{j} f(n,j,z),$$

$$\varphi(w,\theta,z) = w\theta F(w,\theta,z),$$

$$F(x,y,z) = z + \sum_{n \ge 1} \sum_{j \ge 0} x^{n} y^{j} z^{j+1} \sum_{0 \le k \le j+1} f(n-1,k,z),$$

$$= z + x \sum_{n \ge 0} x^n \sum_{j \ge 0} y^j z^{j+1} \sum_{0 \le k \le j+1} f(n,k,z)$$

$$= z + x \sum_{n \ge 0} x^n \sum_{j \ge 0} y^j z^{j+1} f(n,0,z)$$

$$+ x \sum_{n \ge 0} x^n \sum_{j \ge 0} y^j z^{j+1} \sum_{1 \le k \le j+1} f(n,k,z)$$

$$= z + \frac{zx}{1 - zy} \sum_{n \ge 0} x^n f(n,0,z)$$

$$+ x \sum_{n \ge 0} x^n \sum_{k \ge 1} f(n,k,z) \sum_{j \ge k-1} y^j z^{j+1}$$

$$= z + \frac{zx}{1 - zy} F(x,0,z) + \frac{x}{y(1 - zy)} \sum_{n \ge 0} x^n \sum_{k \ge 1} f(n,k,z) (zy)^k$$

$$= z + \frac{zx}{1 - zy} F(x,0,z) + \frac{x}{y(1 - zy)} \sum_{n \ge 0} x^n \sum_{k \ge 0} f(n,k,z) (zy)^k$$

$$- \frac{x}{y(1 - zy)} \sum_{n \ge 0} x^n f(n,0,z)$$

$$= z + \frac{zx}{1 - zy} F(x,0,z) + \frac{x}{y(1 - zy)} F(x,zy,z) - \frac{x}{y(1 - zy)} F(x,0,z)$$

$$= z - \frac{x}{y} F(x,0,z) + \frac{x}{y(1 - zy)} F(x,zy,z)$$

$$F(x,y,z) = z - \frac{x}{y} F(x,0,z) + \frac{x}{y(1 - zy)} F(x,zy,z).$$

Let F(x,y,z) be the unique function that is analytic in x and y around (0,0) and satisfies

$$F(x,y,z) = z - \frac{x}{y}F(x,0,z) + \frac{x}{y(1-zy)}F(x,zy,z).$$

It turns out that we have

$$F(x,y,z) = z \Big( 1 + \sum_{n>0} z^{-n(n+1)/2} x^{-n} y^n (Q_n K - P_n) \Big),$$

where *K* is the continued fraction

$$K = \frac{1}{1 - \frac{zx}{1 - \frac{z^2x}{1 - \frac{z^3x}{1 - \frac{z^3$$

and  $P_n$  and  $Q_n$  are numerators and denominators of the convergents of K:

$$\frac{1}{1 - \frac{zx}{1 - \frac{z^2x}{1 - \frac{z^3x}{1 - \frac{z^{n-1}x}{1 - z^n x}}}} = \frac{P_n}{Q_n}.$$

The recursions

$$P_n = P_{n-1} - z^n x P_{n-2}$$

and

$$Q_n = Q_{n-1} - z^n x Q_{n-2}$$

hold with initial values  $P_{-1}=0$  and  $P_0=Q_{-1}=Q_0=1$ , and we have the explicit formulas

$$P_n = \sum_{j \ge 0} {n-j \brack j}_q (-1)^j z^{j^2 + j} x^j$$

as well as

$$Q_n = \sum_{j>0} {n+1-j \brack j}_q (-1)^j z^{j^2} x^j.$$

We also have the recursion

$$Q_{n}K - P_{n} = (Q_{n-1}K - P_{n-1}) \cdot \frac{z^{n+1}x}{1 - \frac{z^{n+2}x}{1 - \frac{z^{n+3}x}{\vdots}}},$$

which gives us

$$Q_n K - P_n = K \cdot \prod_{k=1}^{n+1} \frac{z^k x}{1 - \frac{z^{k+1} x}{1 - \frac{z^{k+2} x}{\cdot}}}.$$

It follows that

$$z^{-n(n+1)/2}x^{-n}(Q_nK - P_n) = Kxz^{n+1} \cdot \prod_{k=1}^{n+1} \frac{1}{1 - \frac{z^{k+1}x}{1 - \frac{z^{k+2}x}{\cdot \cdot \cdot}}}.$$

With

$$P = \sum_{j>0} \frac{(-1)^j z^{j^2 + j} x^j}{(z; z)_j}$$

and

$$Q(x,z) = \sum_{j \ge 0} \frac{(-1)^j z^{j^2} x^j}{(z;z)_j}$$

(so that K = P/Q), we also have

$$Q_n P - P_n Q = \sum_{k>0} \frac{(-1)^k}{(z;z)_k} z^{(k+1)(k+n+1)+n(n+1)/2} x^{k+n+1},$$

which ultimately yields

$$F(x,y,z) = z + \frac{z}{Q(x,z)} \sum_{n \ge 0} y^n \sum_{k \ge 0} \frac{(-1)^k}{(z;z)_k} z^{(k+1)(k+n+1)} x^{k+1}.$$

and

$$h(w,z) = Q(w,z).$$

In particular,

$$[y^n]F(x,y,z) = \frac{z\sum_{k\geq 0} \frac{(-1)^k}{(z;z)_k} z^{(k+1)(k+n+1)} x^{k+1}}{\sum_{k\geq 0} \frac{(-1)^k z^{k^2} x^k}{(z;z)_k}}$$

for  $n \ge 1$ .

It is worthwhile to consider the limit as  $z \to 1$ . In this case, the original functional equation becomes

$$F(x,y,1) = 1 - \frac{x}{y}F(x,0,1) + \frac{x}{y(1-y)}F(x,y,1),$$

whose solution is

$$F(x,y,1) = \frac{1 - \frac{xF(x,0,1)}{y}}{1 - \frac{x}{y(1-y)}}.$$

Taking  $y \to 0$  only yields the trivial identity F(x,0,1) = F(x,0,1) here, but we note that

$$F(x,0,1) = \lim_{z \to 1} zK = \lim_{z \to 1} \frac{z}{1 - \frac{zx}{1 - \frac{z^2x}{1 - \frac{z^3x}{1 - \frac{x}{1 - \frac{x$$

in this case, which yields

$$F(x,y,1) = \frac{(1-y)(1-2y-\sqrt{1-4x})}{2(x-y+y^2)}.$$

The coefficients are given by the generalised Catalan numbers

$$[x^n y^m] F(x, y, 1) = \frac{(m+2)(2n+m-1)!}{(n-1)!(n+m+1)!}.$$

With the more general initial condition (originally stated as  $\varphi(1,i,z)=z^i$ ), we obtain the analogous functional equation

$$F(x,y,z,i) = y^{r}z^{i} - \frac{x}{y}F(x,0,z,i) + \frac{x}{y(1-zy)}F(x,zy,z,i),$$
  

$$\phi(w,\theta,z,i) = w\theta F(w,\theta,z,i),$$

Set r = i - 1. The solution to this equation is now

$$F(x,y,z,i) = z^{r+1} \left( y^r + \sum_{n=0}^{r-1} z^{r(r+1)/2 - n(n+1)/2} x^{r-n} y^n \frac{Q_n(x,z)Q(z^{r+1}x,z)}{Q(x,z)} + \sum_{n=r}^{\infty} z^{n+1} x y^n \frac{Q_{r-1}(x,z)Q(z^{n+2}x,z)}{Q(x,z)} \right).$$

So we find that

$$[y^n]F(x,y,z,i) = \begin{cases} z^{(r+1)(r+2)/2 - n(n+1)/2} x^{r-n} \frac{Q_n(x,z)Q(z^{r+1}x,z)}{Q(x,z)} & n < r, \\ z^{n+r+2} x \frac{Q_{r-1}(x,z)Q(z^{n+2}x,z)}{Q(x,z)} + [[n=r]] z^{r+1} & n \ge r. \end{cases}$$

for the case i = 1, we have,

$$\phi(w,\theta,z) = w\theta z + \frac{1}{Q(w,z)}w\theta z \sum_{n\geq 0} \theta^n H_n(w,z), h(w,z) = Q(w,z)$$

$$H_n(w,z) := \sum_{k\geq 0} \frac{(-1)^k}{(z;z)_k} z^{(k+1)(k+n+1)} w^{k+1},$$

$$S(w,z) := wz \sum_{n\geq 0} H_n(w,z) = wz \sum_{k\geq 0} \frac{(-1)^k}{(z;z)_k} \frac{z^{(k+1)^2}}{1-z^{k+1}} w^{k+1}, C_2 = -\frac{S(1,\rho)}{h_w(1,\rho)}$$

$$G(\theta) = \frac{\theta \rho \sum_{n\geq 0} \theta^n H_n(1,\rho)}{\rho \sum_{n\geq 0} H_n(1,\rho)}, \sum_{n\geq 0} H_n(1,\rho) = 1 \text{ as } h(1,\rho) = 0.$$

for the general case  $i \ge 1$ , we have,

$$\phi(w,\theta,z,i) = w\theta^{i}z^{i} + \frac{1}{Q(w,z)}w\theta z^{i} \left[ \sum_{n=0}^{i-2} z^{i(i-1)/2-n(n+1)/2} w^{i-1-n}\theta^{n}Q_{n}(w,z)Q(z^{i}w,z) \right]$$

# 6.2. The perimeter conditioned on n. We have here

$$U(k,j) = [[j \ge k-1]], w = j-k \text{ (we have no } z \text{ here)}, T_d = |w_d|.$$

We use the notations:

$$j = k - 1 : E_{w}^{m}(k, j) = 1, E_{w^{2}}^{m}(k, j) = 1, j \ge k : E_{w}^{p}(k, j) = j - k, E_{w^{2}}^{p}(k, j) = (j - k)^{2},$$

$$\overline{\mathbb{E}}^{m}(y) = \sum_{k=2}^{\infty} \pi(k) C_{2}(k - 1) E_{y}^{m}(k, k - 1),$$

$$\overline{\mathbb{E}}^{p}(y) = \sum_{k=1}^{\infty} \pi(k) \sum_{j=k}^{\infty} C_{2}(j) E_{y}^{p}(k, j),$$

$$\overline{\mathbb{E}}(y) = \overline{\mathbb{E}}^{m}(y) + \overline{\mathbb{E}}^{p}(y),$$

$$\mu_{3} = \overline{\mathbb{E}}(w), \sigma_{3}^{2} = \overline{\mathbb{E}}(w^{2}) - \mu_{3}^{2}.$$

We use previous relations as follows

$$\cdot \left\{ \sum_{\ell=2}^{\infty} [M_1(j,\ell) + M_2(j,\ell)] C_2(l-1) F_2^m(\ell,\ell-1) + \sum_{\ell=1}^{\infty} [M_1(j,\ell) + M_2(j,\ell)] \sum_{k=\ell}^{\infty} C_2(k) F_2^p(\ell,k) \right\}.$$
This leads to
$$\sigma_Q^2 = \sigma_3^2 + 2\Xi_5(E_w, E_w) = 0.4485678619...,$$

$$\sigma_X^2 = \sigma_x^2 + 2\Xi_5(j,k) \equiv \sigma_2^2,$$

$$C_{X,Q} = \overline{\mathbb{E}}(j \cdot E_w - \mu_2 \mu_3) + [\Xi_5(j, E_w) + \Xi_5(E_w, k)],$$

$$\mu_3 = 0.6188628379..., \rho_{X,Q} = 0.6289527540...,$$

$$\mu_4 = 1.6103718403..., \sigma_4^2 = 1.0188734817...$$

Again, we have made extensive simulations to check our results. The fit is quite good.

#### 7. The bargraph perimeter

The wall (or bargraph) polyomino (wa) is made of contiguous columns, of any positive size, with all base cells at the same level.




FIGURE 10. A typical wa polyomino.

For wa, we have the following typical example: see Fig.10,

This polyomino is obviously equivalent to a composition of an integer n. In [13], it was proved that it asymptotically corresponds to a sequence of iid Geometric(1/2) RV. We prove it again here, with a different method, more in the spirit of the present paper.

# 7.1. **The generating functions.** We have

$$\phi(w,z) = \sum_{1}^{\infty} w^{m} \left(\frac{z}{1-z}\right)^{m} = \frac{wz}{1-z-wz},$$

$$h(w,z) = 1 - z - wz, \rho = \frac{1}{2},$$

$$[w^n z^n] \phi(w,z) = \frac{1}{\rho^n} [w^n z^n] \phi(w,\rho z) = \frac{1}{\rho^n} [w^n z^n] \frac{wz\rho}{1 - \rho z - \rho wz}.$$

We turn again to the analysis used by Bender in [1]. It is asymptotically based on the GF

$$\phi_1(z) = \left(\frac{t(1)}{t(z)}\right)^m,$$

where t(z) is the root of the denominator of (6), seen as a w equation:

$$w = t(z) = \frac{1 - \rho z}{\rho z}, \phi_1(z) = \left(\frac{z/2}{1 - z/2}\right)^m,$$

This indeed leads to sequence of iid Geometric(1/2) RV.

# 7.2. The perimeter conditioned on m.

with 
$$x_d = j$$
,  $x_{d-1} = k$ , we have here  $w_d = |j - k|$ .

In [19], we have analyzed in great detail the perimeter of sequence of iid Geometric(p) RV, called therein a "geometric word" Using these results, we obtain

$$\mu_{2} = \frac{1}{p} = 2, \sigma_{x}^{2} \equiv \sigma_{X}^{2} \equiv \sigma_{2}^{2} = \frac{1-p}{p^{2}} = 2, \mu_{3} = \frac{2(1-p)}{p(2-p)} = \frac{4}{3},$$

$$\sigma_{3}^{2} = \frac{2(1-p)(p^{2}-2p+2)}{p^{2}(2-p)^{2}} = \frac{20}{9},$$

$$\sigma_{Q}^{2} = \frac{4(1-p)(p^{4}+9p^{2}-4p^{3}-10p+5)}{p^{2}(2-p)^{2}(p^{2}+3-3p)} = \frac{232}{63},$$

$$C_{X,Q} = S_{1} + S_{2} - 2\mu_{2}\mu_{3},$$

$$S_{1} = \sum_{i=1}^{\infty} pq^{i-1} \left[ \sum_{j=i}^{\infty} pq^{j-1}j(j-i) + \sum_{j=1}^{i-1} pq^{j-1}j(i-j) \right],$$

$$S_{2} = \sum_{i=1}^{\infty} pq^{i-1} \left[ \sum_{j=i}^{\infty} pq^{j-1}i(j-i) + \sum_{j=1}^{i-1} pq^{j-1}i(i-j) \right],$$

$$C_{X,Q} = \frac{2(2-4p+3p^{2}-p^{3})}{p^{2}(2-p)^{2}} = \frac{20}{9},$$

$$\rho_{X,Q} = \frac{5\sqrt{2}\sqrt{406}}{174}, \mu_{4} = 5/3, \sigma_{4}^{2} = \frac{173}{189} = .9153439162...$$

Again, we have made extensive simulations to check our results. The fit is quite good.

7.3. **A comparison with known GF.** Now we use Bousquet-Mélou [6, (12)]. If we set q = z, y = 1, x = w in the denominator  $1 - I_-$ , we obtain a function

$$1-z-wz$$

which is exactly h(w, z).

If we set q = z, y = x = v, we obtain

$$F(v,z) = 1 - \sum_{n=1}^{\infty} \frac{v^n (v-1)^j z^{j(j+1)/2}}{(z;z)_n (vz;z)_{n-1}}$$

which leads exactly, by Bender's theorems to  $\mu_4$ ,  $\sigma_4^2$ .

### APPENDIX A. COMPLEMENTS

# A.1. $\varphi$ -mixing property. Let

$$\ldots, \xi_{-1}, \xi_0, \xi_1, \ldots$$

be a stationary sequence of RV. For  $a \leq b$ , define  $M_a^b$  as the  $\sigma$ -field generated by  $\xi_a, \ldots, \xi_b$ , define  $M_{-\infty}^a$  as the  $\sigma$ -field generated by  $\ldots, \xi_{a-1}, \xi_a$ , and define  $M_a^\infty$  as the  $\sigma$ -field generated by  $\xi_a, \xi_{a+1}, \ldots$ 

Consider a nonnegative function  $\varphi$  on positive integers,  $\varphi(n) \to 0, n \to \infty$ . We shall say that the sequence  $\xi_n$  is  $\varphi$ -mixing if, for each  $k(-\infty < k < \infty)$ ) and for each  $n(n \ge 1)$ ,  $E_1 \in M^k_{-\infty}$ ,  $P(E_1) > 0$ , and  $E_2 \in M^\infty_{k+n}$  together imply

$$|\mathbb{P}(E_2|E_1) - \mathbb{P}(E_2)| \le \varphi(n).$$

A.2. **Equation Bousquet-Mélou** [5, (10)]. Let P be a polyomino. Let us mark by s (resp. t) its left height (resp. right height), by x (resp. y) the half-number of horizontal (resp. vertical) steps in its perimeter, by q its area. The dcc generating function G(s,t,x,y,q) satisfies  $((a)_n$  means here  $(a:q)_n)$ 

$$G(1,t,x,y,q) = ty \frac{L_1(1)}{L_0(1)}, \text{ with}$$

$$L_0(s) = 1 - \sum_{n=1}^{\infty} \frac{x^n s^n (y-1)^{n-1} q^{\binom{n+1}{2}}}{(sq)_n (syq)_{n-1} (syq)_n}, \text{ and}$$

$$L_1(s) = \sum_{n=1}^{\infty} \frac{x^n s^n (y-1)^{n-1} q^{\binom{n+1}{2}}}{(sq)_{n-1} (syq)_{n-1}^2 (1-styq^n)},$$

$$G(s,t,x,y,q) = ty \frac{L_1(s) L_0(1) - L_1(1) L_0(s) + L_1(1)}{L_0(1)}.$$

A.3. **Equation Bousquet-Mélou** [5, (29)]. The cc generating function G(s, t, x, y, q) satisfies

$$G(1,1,x,y,q) = y \frac{(1-y)X}{1+W+yX},$$

$$X = \frac{xq}{(1-y)(1-yq)} + \sum_{n=2}^{\infty} \frac{(-1)^{n+1}x^n(1-y)^{2n-4}q^{\binom{n+1}{2}}(y^2q)_{2n-2}}{(q)_{n-1}(yq)_{n-2}(yq)_{n-1}^2(yq)_n(y^2q)_{n-1}},$$

$$W = \sum_{n=1}^{\infty} \frac{(-1)^n x^n (1-y)^{2n-3}q^{\binom{n+1}{2}}(y^2q)_{2n-1}}{(q)_n (yq)_{n-1}^3 (yq)_n (y^2q)_{n-1}}.$$

A.4. **Bender's theorems** 1 **and** 3. Let  $a_n(k)$  be a sequence of non-negative numbers. Let

$$p_n(k) := \frac{a_n(k)}{\sum_j a_n(j)}.$$

We say that  $a_n(k)$  is asymptotically Gaussian (convergence in distribution) with mean  $\mu_n$  and variance  $\sigma_n^2$  if

(7) 
$$\lim_{n\to\infty} \sup_{x} \left| \sum_{k<\sigma_n x + u_n} p_n(k) - \frac{1}{\sqrt{2\pi}} \int_{\infty}^{x} e^{-t^2/2} dt \right| = 0.$$

We say that  $a_n(k)$  satisfies a local limit theorem on a set S of real numbers if

(8) 
$$\lim_{n\to\infty} \sup_{x\in S} \left| \sigma_n p_n(\sigma_n x + \mu_n) - \frac{1}{\sqrt{2\pi}} e^{-x^2/2} \right| = 0.$$

Theorem 1: Central limit theorem

Let f(z, w) have a power series expansion

$$f(z,w) = \sum_{n,k \ge 0} a_n(k) z^n w^k$$

with non-negative coefficients. Suppose there exists (i) an A(s) continuous and non-zero near 0, (ii) an r(s) with bounded third derivative near 0, (iii) a non-negative integer m, and (iv)  $\varepsilon$ ,  $\delta > 0$  such that

$$\left(1 - \frac{z}{r(s)}\right)^m f(z, e^s) - \frac{A(s)}{1 - z/r(s)}$$

is analytic and bounded for

$$|s| < \varepsilon, |z| < |r(0)| + \delta.$$

Define

$$\mu := -\frac{r'(0)}{r(0)}, \sigma^2 := \mu^2 - \frac{r''(0)}{r(0)}.$$

If  $\sigma \neq 0$ , then (7) holds with  $\mu_n = n\mu$  and  $\sigma_n^2 = n\sigma^2$ .

Theorem 3: Local limit theorem

Let f(z, w) have a power series expansion

$$f(z,w) = \sum_{n,k \ge 0} a_n(k) z^n w^k$$

with non-negative coefficients and let a < b be real numbers. Define

$$R(\varepsilon) := \{z : a \le \text{Re } z \le b, |\text{Im } z| \le \varepsilon\}.$$

Suppose there exists  $\varepsilon > 0$ ,  $\delta > 0$ , a non-negative integer m, and functions A(s), r(s) such that

- (*i*) A(s) is continuous and non-zero for  $s \in R(\varepsilon)$ ,
- (ii) r(s) is non-zero and has a bounded third derivative for  $s \in R(\varepsilon)$ ,
- (ii) for  $s \in R(\varepsilon)$  and  $|z| < |r(s)|(1 + \delta)$

$$\left(1 - \frac{z}{r(s)}\right)^m f(z, e^s) - \frac{A(s)}{1 - z/r(s)}$$

is analytic and bounded,

(iv) 
$$\left(\frac{r'(\alpha)}{r(\alpha)}\right)^2 - \frac{r''(\alpha)}{r(\alpha)} \neq 0 \text{ for } a \leq \alpha \leq b,$$

(v)  $f(z,e^s)$  is analytic and bounded for

$$|z| \le |r(\operatorname{Re} s)|(1+\delta)$$
 and  $\varepsilon \le |\operatorname{Im} s| \le \pi$ .

Then we have

$$a_n(k) \sim \frac{n^m e^{-\alpha k} A(\alpha)}{m! r(\alpha)^n \sigma_{\alpha} \sqrt{2\pi n}}$$

uniformly for  $a \le \alpha \le b$ , where

$$\frac{k}{n} = -\frac{r'(\alpha)}{r(\alpha)},$$

$$\sigma_{\alpha}^{2} = \left(\frac{k}{n}\right)^{2} - \frac{r''(\alpha)}{r(\alpha)}.$$

In the proof of Theorem 3, we find, on [1, p.103]), the following result: let  $x := (k - \mu_n)/\sigma_n$ , then

$$\lim_{n\to\infty}\left|\sigma_n p_n(k) - \frac{e^{-x^2/2}}{\sqrt{2\pi}}\right| = 0$$

which is exactly the Local limit theorem (8) we need.
